## SITE INSPECTION - RESIDENTS MEMO



FH Reference: 125592	Project : Berryhill Landslip Remedial Works	Date of Site Visit: 29/12/2020

Mansfield District Council (MDC) have appointed Fairhurst to undertake regular site inspections of the quarry wall between completion of the emergency response works (w/e 24th November 2019) and the commencement of the permanent works in this portion of the quarry in early 2020.

A photographic record of the quarry has been collated and is being updated after each weekly routine inspection.

During a recent inspection on Tuesday 29th of December 2020, the weather was overcast with snowy spells and a dusting (~2cm) of snow on the ground. On days previous to this inspection there had been heavy rain and light snowfall in Mansfield. As per the last site visit on the 24th of December 2020 (undertaken in tandem with the emergency operations from the failure the previous night), the cliff faces were partially saturated with what appeared to be surface water run-off from heavy rain and light snowfall from previous days.

As previously reported, a failure of overburden/completely weathered rock from the upper part of the slope occurred on the 23<sup>rd</sup> December 2020, resulting in mobilisation of emergency response, Fairhurst Engineers and specialist contractors. The failure debris was removed from the rock trap and placed behind the concrete road blocks, installed as a temporary measure in November 2019 following the previous large mass failure.

Since clearance of the rock trap area, it is evident there has been some further small ravelling of soil/weathered rock (See Photograph 1), estimated as less than 2m³ in volume. There are other small areas of residual material which may come down in the coming weeks during precipitation events (including some vegetation/small volume of soil/overburden) although it is anticipated these small ravelling failures will be contained within the temporary works rock trap.

No obvious evidence of tension cracks or mass movement e.g. soil creep was observed at the crest of the quarry face. There was no evidence of significant change in the condition of the quarry slopes from that observed during the Fairhurst site visit inspection of 24/12/20.

Fairhurst are not aware of any reported issues to MDC and the garden herras fencing remained in situ as agreed.






