APPLICATION FOR THE GRANT / RENEWAL OF AN UNLICENSED FAMILY ENTERTAINMENT CENTRE GAMING MACHINE PERMIT AND THE CHANGE OF NAME OF THE PERMIT HOLDER (FOR USE BY OCCUPIERS OF PREMISES INTENDED TO BE USED BY THE APPLICANT AS UNLICENSED FAMILY ENTERTAINMENT CENTRES)

- 1. This form is to be used for an application for a grant, renewal or to request a change of name of a unlicensed family entertainment centre gaming machine permit under the Gambling Act 2005 Section 247 and Schedule 10.
- An unlicensed family entertainment centre is entitled to provide an unlimited number of category D gaming machines available for use on the premises. Prize gaming may also be provided under this permit as long as it meets the provisions of S293 of the Gambling Act 2005.
- 3. The permit's duration is 10 years. A renewal application can be made within 6-2 months before the expiry date of the permit.
- 4. The fee for a new application for grant / renewal is £300. The fee for a change of name request is £25.
- 5. This licensing authority must notify the applicant of its grant / refusal of the application for a permit as soon as is reasonably practicable after that decision to grant / refuse has been made.
