# MANSFIELD DISTRICT COUNCIL CIVIL ENFORCEMENT OFF-STREET PARKING PLACES ORDER 2022

Notice is hereby given that on the 5 July 2022 Mansfield District Council ("the Council") made the Order (the Civil Enforcement Off-Street Parking Places Order 2022 under its powers contained in the Road Traffic Regulation Act 1984 as amended and under the Traffic Management Act 2004 as amended and all other enabling powers. The Order relates to existing off-street parking places provided by the Council at the locations listed in the Schedule of Parking Places and is intended to come into operation on the 22 August 2022.

The Civil Enforcement of Parking Contraventions (County of Nottingham) Designated Order 2008 brought civil parking enforcement into force in the relevant areas of the County of Nottinghamshire, including the District of Mansfield, on 12 May 2008.

The Order will revoke The Mansfield District Council Civil Enforcement Off-Street Parking Places Order 2018, The Mansfield District Council Civil Enforcement Off-Street Parking Places Notice of Variation (No.1) 2019 and The Mansfield District Council Civil Enforcement Off-Street Parking Places Notice of Variation (No.2) 2020 in their entirety.

The penalty charges payable for parking contraventions of the Order will be in accordance with The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022/71.

The Notice of Proposal to make the Order was published on site at each parking place and in the Mansfield Chad on 11 May 2022. The effect of the Order is as shown in that Notice of Proposal.

### **Penalty Charges**

£70 (£35 where paid within 14 days; £105 if paid after service of charge certificate)

For contraventions relating to parking in loading areas, designated disabled person's bay, a restricted area, a permit bay or a bay not designated for that class of vehicle; and for using a vehicle in connection with the sale of goods or services, or causing an obstruction. For parking in a permit bay without clearly displaying a valid permit.

£50 (£25 where paid within 14 days; £75 if paid after service of charge certificate)

For parking without paying the parking charge, for longer than the maximum period allowed, after the expiry of the paid for time, without displaying a valid pay and display ticket, voucher or parking clock, parking beyond the bay markings, returning to the same parking place on the same day within the specified period, parking when parking place is closed, parking for a purpose other than that permitted, parking with engine running where prohibited.
