Appendix 2: Survey Guidance and Useful Contacts

Bird Survey 'Rules of Thumb'

Provided are some basic procedures that should be carried out when conducting breeding and wintering bird surveys. It is important that consultants have addressed the following:

- Before commencing surveys, it is important desk-top searches are carried out first in order to find out if records already exist and information on designated sites. See below for reliable sources of records. NB: by itself, the NBN Gateway is not a sufficient source of information; records should be sought from Nottinghamshire Biological and Geological Records Centre (NBGRC).
- **Breeding bird surveys** should be conducted for nightjars and woodlarks, and **wintering bird surveys** done for woodlarks.
 - Breeding survey methodology should follow that laid out for the relevant species (Gilbert et al).
 - Wintering bird surveys for woodlarks should comprise a minimum of three visits to all suitable areas of habitat in the period November-February. In all other respects follow the generic Common Birds Census (CBC) methodology (e.g. Gilbert et al).
- For specialised surveys required in relation to some specific forms of development (e.g. collision risk assessments for wind farms) please consult with Natural England and other nature conservation bodies at an early stage. Also see Natural England's Standing Advice (see below).
- Conduct Phase 1 habitats surveys. Please see Appendix 1 for more information on species requirements.
