MANSFIELD DISTRICT COUNCIL PROPOSED CIVIL ENFORCEMENT OFF-STREET PARKING PLACES ORDER 2024

Mansfield District Council ("the Council") intends to make the above Order ("the Proposed Order") under its powers contained in the Road Traffic Regulation Act 1984 as amended and under the Traffic Management Act 2004 as amended and The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996/2489 and all other enabling powers.

The Proposed Order relates to existing off-street parking places provided by the Council at the locations listed in the Schedule of Parking Places and Charges below and is intended to come into operation on 00.01 hours on 28th October 2024 (or as soon as possible thereafter)

The Civil Enforcement of Parking Contraventions (County of Nottingham) Designation Order 2008 brought civil parking enforcement into force in the relevant areas of the County of Nottinghamshire, including the District of Mansfield, on 12 May 2008.

The Council intend to revoke The Mansfield District Council Civil Enforcement Off-Street Parking Places Order 2022 and The Mansfield District Council Civil Enforcement Off-Street Parking Places Notice of Variation (No.1) 2023 in their entirety.

The proposed new Order will revoke the aforementioned existing 2022 Order and Notices of Variation, which will give the Council the opportunity to revoke and amend the conditions and use of some existing parking places, to amend the parking charges and periods of parking, support local businesses through improved vehicle turnover and introduce new parking system for Water Meadows customers, in accordance with the attached Schedule of Parking Places and Charges.

The penalty charges payable for parking contraventions of the Proposed Order in accordance with The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022/71 will be as set out below.

Proposed Penalty Charges

£70 (£35 where paid For contraventions relating to parking in loading areas, designated disabled person's within 14 days: £105 if bay, a restricted area, a permit bay or a bay not designated for that class of vehicle. and for using a vehicle in connection with the sale of goods or services, or causing paid after service of charge certificate) an obstruction. For parking in a permit bay without clearly displaying a valid permit. £50 (£25 where paid For parking without paying the parking charge, for longer than the maximum within 14 days; £75 if period allowed, after the expiry of the paid for time, without displaying a valid pay paid after service of and display ticket, voucher or parking clock, parking beyond the bay markings, charge certificate) returning to the same parking place on the same day within the specified period,

parking when parking place is closed, parking for a purpose other than that permitted, parking with engine running where prohibited.

Season tickets for individals per calendar month: Gold (Four Seasons) = £106; Silver (Walkden Street, Water Meadows,Toothill Lane and Church Lane) = £81; Bronze (Robin Hood Line, Grove Street, Victoria Street and Garden Road) = £50;

Contract parking designated surface car parks - reserved spaces per calender month and based on a minimum purchase of 2 passes Gold (Four Seasons) = £75;

Silver (Walkden Street, Water Meadows, Toothill Lane, Church Lane) = £61;
