- Whilst the Planning and Infrastructure Bill is key there are other reforms afoot:
 - Unimplemented provisions of the Levelling Up and Regeneration Act 2023
 - Local Government Reform
- New NPPF published Dec 2024
- Current Government Consultations:
 - Reform of Planning Committees Technical Consultation
 - Planning Reform Working Papers on:
 - Speeding up build out
 - Reforming site thresholds
 - Planning committees
 - Development and nature recovery
 - Brownfield passport
 - > Improving the implementation of BNG for minor, medium and brownfield development



Other News

- Development Management processed around 700 applications 2024/5.
- We were cited in a planning publication as having a high rate of approvals, ranked joint 11th in the Country with the highest approval rates in the year to Dec 2024
- We are making good progress on the Local Plan Review Reg 18.
- Backlog Officer post was successful, and we did manage to clear the majority of the historic backlog in planning applications
- We have been successful in receiving a grant for £228,000 to help deliver the local plan review
- We have been successful in attaining £27,000 for BNG funding
- We have introduced Mycelia to assist in the validation, assessment and monitoring of BNG, although BNG remains a challenge
- We are going out for recruitment for an Assistant Director who will be the Chief Planning Officer this will give a clear focus on Planning in Mansfield





Towns Fund

- £12.32M secured
 - Destination Mansfield
 - SMART Mansfield
 - Warsop Health Hub
 - Destination Park at Berry Hill
 - Future Technology Knowledge and Skills Exchange
- Over £23M of investment in the district



Levelling Up Fund – Mansfield Connect:

- A multipurpose civic and community hub at the heart of the town centre, c. £33.5M
- Re-activating Mansfield town centre, driving transformational change in service delivery, breeding a new confidence in the town and unlocking our entrepreneurial spirit
- Progress on strip-out, asbestos removal and demolition
- Redesign underway to account for structural and condition issues
- Strong partnership engagement

National Lottery Townscape Heritage Programme

- 11 buildings being improved across the town centre area re-purposing many and refurbishing others
- 2 more under consideration, linked to a town centre marketplace upgrade

- £76 million in Mansfield on nature-based solutions to protect communities from flooding.
- Created a partnership with Mansfield District Council and Nottinghamshire County Council.
- Provided storage for >31 million litres of surface water.
- Creating a blueprint for how we can manage future flood risk Sustainable Drainage Solutions.
- Making Mansfield an even greener place to live for our customers and communities.

SuDS OVERVIEW

SuDS deliver a wide range of benefits whilst tackling some of our key challenges

Environmental



- Reduce frequency and magnitude of storm overflow activations
- Accommodates impact of climate change and society
- Helps naturally clean surface water
- Energy and carbon reduction
- Create habitat & biodiversity net gain.

Socio-economic



- Reduced flooding risk for local communities
- Creation of local jobs
- Partnership funding opportunities
- The green spaces created deliver health & wellbeing benefits
- Town centre cooling

Application



- Variety so can be flexed to accommodate the local environment
- Interventions are highly scalable, ranging from small planters to large detention basins
- Faster and less disruptive to implement than large scale conventional solutions

BIOSWALES

Bioswales can be effective, medium scale interventions.



- 143 bioswales constructed to date, providing over 14.7 million litres of additional network storage.

Basin constraints:

- Land availability
- Buildability/construction access.
- Topography to transfer surface water
- Planning Permission & flood route risk
- Ecology & BNG

Classification: OFFICIAL SENSITIVE **PERMEABLE PAVING** We have developed a new permeable paving standard, accepted by local authorities for installation within their asset base & constructed 104 interventions worth nearly 2.9million litre of storage.



VERGE AND STREET RAINGARDENS

We have now built a range of highways interventions include raingardens in both verge and street locations.

- Effective solution for surface water interception, VRG and SRG's proved highly effective at capturing and retaining surface water in storm events.
- 70 rain gardens worth 932m3 of storage.
- However, it is clear that urban small-scale streetscape interventions, like street rain gardens, have proved both costly to construct and unpopular in some locations.

DEVELOPER OPPORTUNITY PILOT – CENTENARY ROAD





- Brownfield site Demolished former terrace properties.
- 77 new council property dwellings under design & build by MDC.
- SuDS Interventions (in highway and public open space).
- MDC incorporated SvT SuDS into the design providing 165 m3* network storage equivalent volume *including* private permeable paving
- All private interventions (perm paving) remain housing assets.
- The developer's Flood Risk Assessment storage requirement (100 year + CC%) has been significantly reduced from 375m3 to 209m3, a 44% reduction in volume with exceedance routes from SuDS to FRA conventional storage provision.

BUILDING & DEVELOPING

Environmental Incentive Scheme 2025-26

- Leaving a lasting legacy for future generations
- The nature of what we do as a company means we have an important role to play in protecting and sustaining water as a natural resource for future generations. We want to encourage better water efficiency in the home. We also wish to aid the prevention of flooding. Our new Environmental Incentives aim to support this.
- As a home builder, you could receive a financial incentive by building new homes to specified qualifying criteria.
- Our Environmental Incentives are reviewed annually and will be paid at the prevailing year's rate, based on the date you apply for the incentive.

Reviewing Local Plans

- Government requires every Local Plan to be reviewed at least once every five years
- This is to ensure that policies remain relevant and effectively address the needs of the local community
- Having an up-to-date plan helps protect against speculative and unplanned development



Mansfield Local Plan Review

Local Development Scheme (LDS) – adopted 4 March

Key milestones	When	
Public participation (Reg 18)	Opportunities for interested parties and statutory consultees to consider the options for the plan before the final document is produced.	May 2025 for six weeks
Pre-submission (Reg 19)	The council publishes the Local Plan Review which is followed with a six-week period when formal representations can be made.	April / May 2026
Submission	The council submits the Local Plan Review to the Secretary of State together with the representations received at Regulation 19 stage.	June 2026
Independent Examination / Inspector's Report	Held by a Planning Inspector into objections raised at Regulation 19 stage. Will result in a report regarding whether the Local Plan Review is 'sound' or 'not sound'. The Inspector may make recommendations to make the plan 'sound'.	July 2026 – January 2027*
Adoption	The council will formally need to adopt the Local Plan Review and it will then be used in making planning decisions.	March 2027*

- Consultation on methodology and call for sites
- 223 sites assessed 159 identified as 'potential sites'
- Estimated yield of c16,500 homes and c500,000 sqm economic floorspace
- Consultation, further evidence gathering and testing will allow us to refine these into site allocations.

Purpose of LNRS

- New statutory system: spatial strategies for nature's recovery 2021 Env't Act
- Locally-led, transparent and collaborative – 48 in England
- Map the most valuable existing areas for nature
- Agree priorities for nature's recovery
- Map specific proposals for creating or improving habitat for nature and wider environmental benefits







Governance and Oversight

- Nottinghamshire County Council = Responsible Authority
- Supporting Authorities =
 - City Council, unitary
 - 7 x District & Borough Councils
 - East Midlands Combined County Authority
 - Natural England
- County Council Cabinet approval
- Strategic Oversight Group







Stakeholder Engagement 2024

- Facilitated by RSK Nature Positive
- Engagement workshops May to Oct 24
- Public events Notts Day & Victoria Centre
- Farmer events Ploughing Matches
- Online survey and interactive map
- Images used to help identify priorities
- Explore barriers and enablers to nature recovery











Key Findings of Engagement

- Nature-rich spaces in urban areas, with clear accessibility and 'looked after/safe'
- Water, trees and animals key future vision
- Recognition of competing land uses in wider landscape – agriculture, renewable energy and need for housing and infrastructure
- Good understanding of benefits of nature recovery
- Need funding for nature recovery
