Mansfield District Local Plan: Submission

I am pleased to submit the Mansfield District Local Plan to the Secretary of State for Examination, in accordance with Section 20 (1) of the Planning and Compulsory Purchase Act 2004 and Regulation 22 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

The Council considers that these do not materially alter the substance of the Local Plan publication draft and do not impact upon the overall Sustainability Appraisal or other impact assessments.

The publication draft Local Plan was supported by the Whole Local Plan and Community Infrastructure Levy Viability Assessment 2018 (V1) however further evidence has been commissioned and will be submitted once available. It is also proposed to combine the Housing Technical Paper 2018 (H1) and Housing Technical Paper Addendum 2018 (H2) into a Housing Topic Paper to support the Examination process and will be submitted in the New Year.

I can confirm that notification of the submission of the Local Plan will be sent to all those persons who made representations on the Local Plan Publication Draft (Regulation 20), this will take place as soon as reasonably possible.



The Council formally request that, in accordance with Section 20 (7C) of the 2004 Planning and Compulsory Purchase Act (as amended by Section 112 of the Localism Act 2011), the Inspector present modifications needed to ensure that the Local Plan is 'Sound'. A number of proposed modifications have been submitted alongside the Local Plan for submission many of which the Council consider are minor.

At this stage it is anticipated that hearings could commence at the end of May 2018 to take account of the local elections and arrangements are in place to ensure key staff availability at this time. The hearing sessions are expected to last approximately three weeks. The proposed venue for the examination hearings is the Council Chamber at the Civic Centre. This is publicly accessible and has previously been used effectively for planning appeal hearings. In the event that the hearings attract large numbers of people, alternative venues will need to be considered in consultation with the Inspector.
